## 2021 WATER QUALITY REPORT FOR THE CITY OF GRUNDY CENTER

The City of Grundy Center strives to provide you with a safe, dependable supply of drinking water that is in compliance with the guidelines established by the Environmental Protection Agency (EPA). This report contains important information regarding the water quality in our water system. The City of Grundy Center currently purchases its water through a bulk connection with Iowa Regional Utilities Association (IRUA). The Marshalltown Water Works supplies the water which is pumped from nine deep wells located on the north side of the Iowa River drawing from the Buried Sand and Gravel aquifer and the Mississippian aquifer. Our water quality testing shows the following results:

Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your drinking water, you may wish to have your water tested. ### SOURCE WATER ASSESSMENT INFORMATION

The Marshalltown Water Works obtains its water from the buried sand and gravel of the Buried Sand and Gravel aquifer. The Buried Sand and Gravel aquifer was determined to have low susceptibility to contamination because the characteristics of the aquifer and overlying materials provide natural protection from contaminants at the land surface. The Buried Sand and Gravel wells will have low susceptibility to surface contaminants such as leaking underground storage tanks, contaminated spills, and excess fertilizer application.

Marshalltown Water Works also pumps water from the limestone and dolomite of the Mississippian

aquifer. The Mississippian aquifer was determined to be susceptible to contamination because the characteristics of the aquifer and overlying materials provide some protection from contaminants from the land surface. The Mississippian wells will be susceptible to surface contaminants such as leaking underground storage tanks, contaminants spills, and excess fertilizer application. A detailed evaluation of your source water was completed by the Iowa Department of Natural Resources, and is available from Iowa Regional Utilities Association at (641) 792-7011.
