The Grundy Register GRUNDY COUNTY- The simple act of stepping outside has become a hazard as some of the coldest temperatures to ever hit the area are projected in the horizon in Grundy County.

"This is a typical bad storm for us. I don't know how else to put that," County Engineer Gary Mauer said. "It hasn't happened for three or four years,

## Sheriff's office warns residents to avoid travel, take precautions this week

Despite the mixture of sleet, snow, ice, strong winds and sub-zero temperatures, Grundy County Sheriff's Chief Deputy Tim Wolthoff says the department hasn't really seen a spike in accidents over the last week, mainly due to drivers taking precautions while on the road.

"It seems like when people know this stuff is coming, they take notice, slow down and drive cautiously, so we haven't really had too many accidents because of weather," Wolthoff said. "It's when we get those unexpected bursts of snow or bad weather that all of a sudden, people go sliding into the ditch because they're going too fast or not being as careful."

But with more bad weather - mainly dangerously low temperatures - heading towards the area during the middle part of this week, law enforcement and See WEATHER page 2

safety officials are reminding citizens to take safety precautions this week.

Currently, there is a wind chill warning in effect for the coverage area, which is set to last through Thursday.

With the wind chill, the real feel temperature is expected to dip as low as 60 below zero meaning frostbite on exposed skin could occur in as little as five minutes and could be life threatening.

According to the National Weather Service, an extended and rarely seen outbreak of extreme cold and dangerous wind chills will impact the state through Thursday morning.

"Those venturing outside for any extended period will be in a potentially life threatening situation and should take appropriate precautions," the report states. "Please continue

# **Residents voice opposition to DOT proposed three lane conversion**

#### Waterloo man charged in Johns murder **BV ROBERT MAHARRY**

CHARLES CITY- A Waterloo man who had long been suspected as a person of interest in the 2017 death of Michael Johns has been formally charged with first degree murder, according to a press release issued by the Iowa Division of Criminal Investigation.

Armando Adame III, 27, who is currently serving a prison sentence on federal gun charges, was arrested on Tuesday as the result of a joint investigation between the Iowa DCI, the Grundy County Sheriff's Office and the Floyd County Sheriff's Office, after a warrant was issued on Monday. Johns, a 28-year-old Grundy Center man, went missing for over a month before his body was found south of Charles City on December 1, 2017.

An autopsy revealed that Johns died by a shotgun wound to the head in a manner consistent with a homicide. The criminal complaint against Adame, which was released on Tuesday, indicates that video, cell phone and witness records indicate that he, Johns and another individual were seen together on October 25, 2017, and traveled in the areas around Black Hawk, Grundy, Tama, Butler, Marshall, Buchanan and Floyd Counties. The last traceable activity on Johns's cell phone occurred at 6:05 a.m. that morning.

in Grundy Center, and could even create more problems than it solves.

It all kicked off at last week's Grundy Center City Council meeting, when council members reviewed a recent TEAP (Traffic Engineering Assistance Program) study conducted by the DOT to address the issue of speeding on G Ave.

Council members directed Police Chief Doug Frost to commission the study from the DOT over a year ago to find possible solutions for the speeding problem on Grundy Center's main street.

When the city got the results of the survey back, the DOT suggested not to lower the speed limit or add more stop signs, but to convert G Avenue/Highway 175 from a four lane road into a three lane road, starting at the west edge of town and spanning to the Highway 14 intersection. In the recommendation, the DOT stated that the conversion would

improve safety of drivers and pedestrians compared to a four lane road, and noted that a three lane conversion has been shown to reduce crashes by up to 50 percent.

#### Strong objections

After council members discussed the recommendation from the DOT at last week's meeting, The Grundy Register detailed the discussion in a story that ran on January 24th. When that story was posted online through the Grundy Register's Facebook page, citizens came out to voice their opinions on the topic - with the vast majority of their comments opposing a conversion.

One commenter was Gary Ciddio - a resident of Grundy Center who has lived on G Ave. for over a decade - who said he thinks the DOT's suggestion of a conversion is a bad idea.

"I have lived on G Ave. for over 17 years," Ciddio wrote. "I am very aware of traffic flow

outside my front door. Yes it's true, most cars traveling on G Ave. are going at least five miles per hour over the posted speed limit - a few more maybe a little faster. I think the DOT's proposal is a knee jerk reaction without much thought on how it affects our community. Their solution is just a bad idea. Traffic needs to be slowed down as it is coming in from the west side of town. A permanent stop sign at

the swimming pool intersection would help. Also, we see most kids crossing G Ave. to arrive/ leave the elementary school are doing so at 9th St., since thats the side the front door is located. A crosswalk and stop sign is needed at 9th St. more than at 10th St. Finally, law enforcement needs to start writing more speeding tickets on Main St. If they don't have the manpower I suggest they consider doing what Waterloo has implemented - use speed cameras to catch speeders. One hundred percent of the monies generated from this program go directly into their city's general fund."

# Wellsburg Fire Dept. purchases Thermal Imaging Camera

WELLSBURG - For small town, volunteer fire departments like the Wellsburg Fire Department, it can be hard to find enough money in the city budget to purchase necessary equipment - but that doesn't mean there's not a need for that equipment.

Luckily for the Wellsburg Fire Department, a dedicated fundraising team and lots of support from the community means that the department is able to keep their equipment up to date, and purchase new equipment when needed.

Just recently, the Wellsburg Fire Department was able to purchase a Thermal Imaging Camera. This high tech piece of equipment converts infrared waves from heat into a video or image that department members can use for a variety of purposes - from search and rescue, to finding hot spots.

Chase Babcock, a member of

the Wellsburg Fire Department. says the new camera will help move the department forward and help them on calls.

"You can use the camera for a lot of different things," Babcock said. "One thing you can use it for is search and rescue. So, if a child were to wander off into the woods or into a field, we could use the camera to detect body heat and locate the child. It will even show you foot prints or hand prints, anywhere where body heat was left. You can also use it to find hot spots, and if you're at a fire, you can use it to make sure nothing is burning anymore - not even the smallest flame."

The new camera cost close to \$8,000, Babcock said, and was purchased using funds raised by the Wellsburg Fire and Rescue Association (which is a group of volunteers dedicated completely to fundraising for the needs of the Wellsburg Fire Dept.) and from donations from community members and local business-

es - including a recent donation of \$500 from Green Belt Bank and Trust.

Babcock - who is also a member of the Wellsburg Fire

and Rescue Association - says it's thanks to the support of the community that the department is able to purchase these kind of

# Knudsen to be resentenced on February 4 By: ROBERT MAHARRY

GRUNDY CENTER- A rural Cedar Falls man who was convicted of sexual abuse in Grundy County in 2017 and sentenced to life in prison will be resentenced on Monday after an Iowa Court of Appeals judge ruled that it could not be determined whether he entered into a prior offense stipulation knowingly and voluntarily.

Paul Knudsen, now 40, has been incarcerated since the dramatic four-day trial in Grundy Center two years ago, which included graphic depictions of the aforementioned acts over a period of several years. A jury took less than an hour to return a guilty verdict on three counts of Third Degree Sexual Abuse (each a Class C Felony) and one count of Lascivious Conduct with a Minor, a serious misdemeanor.

In November, the Court of Appeals rejected the evidentiary complaints (including a claim that the victims had previously been abused by a separate perpetrator who wasn't mentioned due to "Rape Shield" laws) and charges that the state suppressed expert testimony in Knudsen's motion, filed by State Appellate Defenders Mark C. Smith and Vidhya K. Reddy. It did rule, however, that a sentencing enhancement resulting in a term of life imprisonment-due to a prior sexual abuse conviction 11 years earlier-would be reversed and that "on remand, Knudsen may enter into a new stipulation regarding the prior offense compliant with Harrington (a case establishing See KNUDSEN page 3

but we've been through these types of storms."

Wednesday's predicted low of 30 degrees below zero would come close to an all-time record, and wind chills are expected to dip as low as 55 below as snow continues to fall. According to Mauer, his crews have been working 13-hour days, and they won't be running machinery on Wednesday due to the freezing conditions. County residents, he added, have been understand-

"We've had some minor breakdowns, but the colder it is, the more brittle the steel gets," he said. "So we're trying to avoid a major breakdown or catastrophe."

And for local school superintendents, two of whom are in their first year on the job, the weather has thrown a wrench into their plans. Along with county road crews and transportation directors, they're some of the first to drive out in the morning (as early as 3:00 a.m.) to examine the conditions and determine what to do next.

Grundy Center has been off for six days and counting, and Superintendent Neil Mullen said the only time he can remember something comparable was in 2008 at Union of La Porte City, when the district closed for 12 days.

"The ditches are full of snow currently which makes it very difficult to travel on gravel roads when the wind is blowing," Mullen said. "Add the terrible temperatures and wind chill, and we have some very dangerous conditions."

As BCLUW's Ben Petty explained, the chief consideration is always student safety. His district has already missed five days heading into February, which is the most by that date during his eight years as superintendent.

#### snow forecast or that has occurred might be less important for road conditions and student safety than what the winds are doing (or expected to do later in the day)," he said. "The timing of the storm, along with how long it can be expected for county plows to get out on the roads after a storm also plays a

role in the decision.' Dike-New Hartford Superintendent Justin Stockdale has taken to social media to detail his decision making process, and he says he's received positive feedback for being thorough.

"I want to see it myself," he said. "It's just my preference. When (others) see it, there's zero questions about why you make the decision.'

Gladbrook-Reinbeck has called off six days, and Superintendent David Hill said the district hasn't faced a predicament like this in several years. "We want to have the kids in

school, but we simply must prioritize student safety," he said.

AGWSR Superintendent Erik Smith noted that because of his district's massive geographical size, safe transportation is of utmost importance, and he has already cancelled classes four times in the last two weeks.

"We have a very large district and our busses will could be 10 miles or more from one of our attendance centers, which makes driving to get students off a stalled or stuck bus difficult and time consuming," Smith said. "Each storm is unique, which means using one standard to make every decision doesn't always work, but making sure I have as much information as possible is important."

Relief is imminent, however, as forecasts are calling for temperatures as high as 40 degrees by the weekend. But as residents of this state have certainly learned by now, schizophrenic weather patterns come with the

to monitor the latest forecasts and updates to current warnings, advisories and watches. In addition, strong winds will create areas of blowing snow; especially across portions of east central and northern Iowa where the heaviest snow fell Sunday night and Monday. Impacts will include snow covered and slippery roads along with reduced visibility to 1 mile or less at times."

Wolthoff suggested citizens stay inside if possible and avoid traveling or going outside.

"If you have to go out, make sure you have a full tank of gas, a strong car battery and a fully charged cell phone. Make sure you're adequately dressed, and are wearing boots, gloves, a hat and other protective clothing," he said. "If you can, prepare an emergency kit for your car that includes a shovel, sand, rock

responders trying to get around traffic, parking issues downtown and issues with loading and unloading trucks and semis on main street - with many pointing to the controversial three lane conversion in Waverly.

Matthew Schneider, a Waverly resident who is in charge of a Facebook page called Keep Waverly Moving (a group that is attempting to reverse the three lane conversion in Waverly and make statewide legislation against future three lane conversions) says that although he believes the conversion hasn't worked for Waverly, that's not to say it couldn't work in other places.

"Bremer Ave. in Waverly [the site of the recent conversion] and G Ave. in Grundy are two very different roads," he said. "Traffic is a lot different. Here on Bremer Ave., the conversion has caused more issues than it solved, even if it was unintentional. There's nowhere to divert traffic, unless you want to take a two or five mile detour, and there are long lines of traffic backed up to a mile or more at times. We've also seen more accidents both on Bremer and citywide. We've talked to emergency responders who have told us it's not working for them. Most small town emergency responders are volunteers, and if they're trying to get to the fire station or ambulance, they're in their personal vehicles and they're at the mercy of the speed of the vehicle leading the pack. That can slow down emergency response times."

Schneider says in Waverly, the conversion has become a messy issue that's spiraled out of control, but that Waverly's situation is hard to compare to other situations.

"Each town is different and you can't really compare them," he said. "Waverly is different than Cresco, and Cresco is different than Grundy Center. But, if I was a citizen in Grundy Center, there are measures I would want to try first before I would introduce a road diet/three lane conversion."

#### Law enforcement: there's no easy fix

Grundy Center Police Chief Doug Frost says even before the TEAP study was done, the city looked at other options of slowwere going."

In addition, the mobile speed trailer is run on a solar powered battery, making it basically unusable in the colder winter months or cloudy days.

In response to residents calling for more stop lights, stop signs or speed cameras on G Ave., Frost says the city originally thought of pursuing more stop lights or stop signs when they ordered the TEAP Study from the DOT.

But, since G Ave./Highway 175 is a state highway, the DOT would have to give their blessing to add stop lights or stop signs on the road, and as of now, the DOT is suggesting a three lane conversion instead.

Ultimate decision lies with the city

The DOT's recommendation for a conversion, though, is just that: a recommendation. Ultimately, the city will be the entity to decide whether or not they want to go forward with the conversion, and as of now, council members agree that they would like to do more of their own research on the topic before moving forward with anything.

Mayor Al Kiewiet stressed that the discussion is only informational and preliminary for now, and that the city will not be making any decisions about it right away.

"The recent introduction of the 'Road Diet' to the council was only meant to be an informational and preliminary discussion," Kiewiet said. "The city will need to discuss this idea and do the necessary due diligence to determine if this is indeed the right thing for our community. Our process will take into consideration input from a variety of people including public safety, EMS, fire, local businesses and homeowners on and near the Highway 14/175 route, and the general public. We will also reach out to other towns who have faced the same DOT recommendations. We want to make sure that community members have access to as much accurate information as possible and to assure our residents that decisions being made at the City level are researched, wellthought out and accounting for all possible outcomes and effects

on the City of Grundy Center." Council member Butch

light at the pool crossing, which would help make it safer for children to cross.

"The obvious benefit is that three lanes slows down traffic," she said. "Some benefits that folks might not have considered is that when our kiddos cross the highway by the pool, the traffic coming upon that [crossing] would be moving considerably slower. There would be a push button stop light at that corner, and I agree with them about that."

Miller says she can speak about the safety of that area from personal experience, as her son was hit by a car at that intersection.

"My oldest son Sage was hit by a car at that intersection when he was a kid," Miller said. "Thankfully the car was rolling through on a California stop and he wasn't hurt, but it caused me to be concerned about the speed of traffic through our main street. Business owners and other citizens have voiced their concern about the speed of traffic that moves through Grundy Center. These concerns are what led to to the traffic study and the recommendations from the DOT."

Miller said she will be doing her research on three lane conversions to get the most information possible about how it could work in Grundy Center, before making any decisions.

"I have visited Manchester and plan on visiting other communities that have made the transition," she said. "I've talked to some citizens and it appears that the initial response seems negative. I'm not surprised. Change is difficult. I will be sure to be completely informed, and I hope our citizens will do the same before making a conclusion."

**DOT:** conversions improve safetv

Tony Gustafson, P.E., who is the Assistant District Engineer for the DOT's District 1 - which includes Grundy County - says the push for three lane conversions across Iowa is because the conversion has been shown to increase general safety.

"There's been years and years of research and studies done that have shown three lanes are safer for drivers and pedestrians, and they've even been shown to reduce crashes by up to fifty percent," he said. "General safety is our biggest thing. Even for a town like Grundy Center, it's not a town with the highest crash rate, but it's about predicting and preventing future crashes and doing what we can do increase safety in general." On the Iowa DOT website, information about three lane conversions states that the conversion has a number of benefits: it has been shown to reduce crashes by about half; it has been shown to decrease left turn and rear end crashes because of the dedicated center turn lane; it provides the opportunity to make enhancements such as parking or bike lanes; it can improve walkability by having fewer lanes for pedestrians to cross, along with traffic being located further from the sidewalk; and it can regulate speed and calm traffic, as speeds are more consistent with just one lane in each direction. Gustafson said the three lane conversion suggestion from the DOT is not mandatory, and is simply a suggestion from the DOT to the city of Grundy Center, which the city can act on as it likes. "A three lane doesn't work everywhere, but for a town like Grundy Center with less than 5,000 vehicles passing through a day, a three lane would be easily doable," he said. "Ultimately the council will have the final say on it, though. We just offer it to them and give them information, but they are the ones who will decide.

# Supervisors hash out budget details

GRUNDY CENTER- The Grundy County Board of Supervisors heard its final round of budget requests and got to work on parsing the numbers during Monday morning's regular meeting.

Katie Thornton-Lang and Michelle VanDeest of Grundy County Public Health presented first and laid out their budget along with some of their recent work. GCPH recently received a \$3,700 grant for suicide prevention, which they hope to implement at all of the county's high schools, and Thornton-Lang told the board it came as a surprise.

"I was literally doing dances in the hallway that day. We did not expect that," she said.

In response to a question from Supervisor Jim Ross, Thornton-Lang noted that the anti-vaccine movement has not been a major problem in Grundy County, but there are a few religious and medical exemptions each year. The widely discredited claims of a link between vaccines and autism, however, have been difficult to deal with at times.

"It seems like the negative gets out there more than the positive, and that's what stays with people," Thornton-Lang said.

VanDeest thanked County Auditor Rhonda Deters and her staff for their excellent working relationship and stressed that communication had never been better.

Northeast Iowa Area Agency on Aging Director Cara Ferch requested just over \$3,000, though the official figures varied, and she explained some of her group's Meals on Wheels initiatives and programs designed to benefit local seniors.

Todd Rickert briefly outlined his social services budget, and

community a lot, and their support is always great," he said. "I think the community realizes that we're here to serve them, and they understand that this equipment helps, even though it's not cheap. We're so lucky to have their support."

Deters discussed an uptick in passport business along with a state law that she believes could adversely affect cities, schools and counties as they hold elections.

"As passports and job responsibilities grow, something's got to give," Deters said. "We're busting ourselves every day."

Deputy auditor Angie Martin added that the process can be lengthy, and some people come from other counties (specifically Black Hawk) because of the efficiency of the passport system here in Grundy County.

Deters then mentioned that she had received correspondence from Gladbrook-Reinbeck Superintendent David Hill about the new laws combining city and school elections and how they could negatively impact local decision making.

She is currently serving on a committee of county auditors tasked with finding solutions.

"It's a political hot potato, and (legislators are) not going to touch it. I'm not very confident that we're going to be able to come up with something that's going to be voluntarily adopted by 99 counties," Deters said. "I'm very concerned for our cities and schools.'

Deters later noted that Grundy County has some of the oldest election equipment in the state, and it may be time to consider purchasing something new.

As the conversation shifted toward the budget numbers themselves, Supervisor Barb Smith said she was against a proposed \$10,000 increase in annual funding for the Grundy County Fair because of the subsidy rate compared to other counties and suggested keeping it at \$50,000.

"I'm totally favorably inclined, but I just can't support that," she said. "(But) I love their enthusiasm and their inventiveness about creating new revenue streams.'

are to purchase new extrication is best equipped for our volunequipment and a new skid unit for the department's grass rig.

"We'll be doing our annual fundraisers like our golf tournament, pancake breakfast and things like that, and we're hoping to really get to work on getting some grants, too," he said.

Supervisor Chuck Bakker told the board he was opposed to the proposed card security system at the courthouse after a quote came in at just under \$11,000, and he and Smith revived their recurring debate over county funding for Grundy County Memorial Hospital (GCMH).

Bakker, who represents the Dike and Stout areas, has long held that the hospital should receive less funding as it is doing fine financially.

She replied that because it is one of just two veteran's memorial hospitals in the state, GCMH can't directly levy taxes, but the \$263,000 it receives still ranks near the bottom in county support.

"It's an asset to the county," she said.

On another familiar issue, Ross, a frequent critic of the Grundy Road paving project who represents the southwest corner of the county, reported that among the constituents he's spoken with, "nobody approves" when the topic comes up in discussions.

The board also considered grants for soil and water conservation, tourism, economic development, emergency management and discussed insurance contributions for employees.

IN OTHER BUSINESS, the board:

• Approved a low fuel quote from Mid-Iowa Cooperative.

• Approved a resolution to vacate a portion of K Avenue from 160th Street to the Highway 20 intersection after a brief public hearing.

Frost says the department is already extremely busy, and that it's hard to have an officer patrolling the road 24/7 when there are other issues to deal with.

"Our calls are way up, and they have been for a while," he said. "We're so busy with calls for service and casework and other things that pull us off the street, so we can't always do as much with traffic and enforce it as much as we'd like. With only one officer at a time in 12 hour shifts, we can't be everywhere at once."

Frost says the department has tried using the mobile speed trailer, which shows drivers how fast they are going and if they are speeding, but that even that doesn't work 100 percent of the time.

"Some people see how fast they're going and slow down, other people just ignore it or aren't paying attention," he said. "A lot of people might be driving and so focused on their own thoughts they don't even notice it. I've been driving that road in the marked patrol car and had people fly by me, and when I pull them over and ask why they're going so fast, they tell me they were just lost in their thoughts, thinking about work, or family or something like that, and they didn't even notice how fast they

Kuester said there are pros and cons of a possible three lane conversion, but that there are a lot of factors to consider before he feels comfortable making any decisions.

"I believe one benefit of the three lane would be that it would slow traffic down, but on the down side. I believe that the one lane of traffic would really cause problems with parallel parking and also with unloading of deliveries [on main street by large delivery trucks and semis]," he said. "Also in our Ag-based community, with the two businesses of Titan and Van Wall, the combines and planters are not getting smaller, and the farmers coming through town would have a really hard time maneuvering the three lane road."

Kuester says he has had quite a few people that have commented on the three lane conversion to him, saying they were not in favor of it. He said it's important to keep residents' concerns and opinions in mind before making any decisions.

"I plan on visiting some towns that have done the three lane and also some that have parallel parking [to see it for myself]," he said. "I believe we need to take all scenarios in to consideration."

Council member Janetta Miller said she could see how a three lane conversion would be beneficial in slowing down traffic, especially where children are crossing the highway by the swimming pool. She noted that in the DOT's recommendation for a three lane conversion, they also recommended adding a push button pedestrian crossing

but denied any knowledge or involvement, and during a search, an illegal sawed off 12-gauge shotgun was found at his residence.

The Iowa DCI's lab analysis revealed that some of the 12-gauge ammunition in Adame's possession was within the size range of the wound found on Johns's body at the time of his death.

The other individual who was with Johns and Adame on October 25 told investigators that the two had gotten into an argument inside the vehicle, and Adame had pulled Johns out of the car and shot him fatally with a sawed off shotgun.

According to court documents signed by DCI Special Agent Scott Reger, Adame had previously been convicted of both Conspiracy to Commit a Forcible Felony and Felon in Possession of a Firearm in 2008 and 2015, respectively. The 2008 case stemmed from a home invasion and robbery at a Waterloo apartment, during which Adame, who was 16 years old at the time, and two accomplices allegedly tied up the occupant and stole two video game systems, a television and a computer. In May of 2018, Adame pled guilty to two of the most recent weapons charges-Felon in Possession of a Firearm and Possession of a National Firearms Act Device Not Registered to Possessor—in the U.S. District Court for Northern Iowa in Cedar

# Armadillos-coming soon to a place near you?

Director I told you last week that Tyson Brown had two interesting animals to talk about when he had stopped by the office. Well, this week's column is about the second. He had pictures of a Dasypus novemcinctus!!!!

That is an animal related to sloths and anteaters. In this case, it is the scientific name for the Nine-banded Armadillo. Loosely translated, "armadillo" means "little armored one" in Spanish.

But armadillos in Iowa? Yes, Tyson had pics of one killed by a combine in a cornfield in Marshall County. I was told that this was the farthest north report this year. 2018 seemed to be a year with increased sightings of armadillos in Iowa. "We're not sure how they will affect native wildlife likes plants and animals here," according to Todd Gosselink, Wildlife Biologist with the Iowa DNR. "We'll just have to wait a few years and see if they are in fact heading north."

Their closest populations are in southern Missouri, a bit of a trek for the little armored ani-

They typically weigh between 11 to 14 pounds. Each year, armadillos can eat up to 200 pounds of insects, which consist of 90 percent of their have impressive claws, which diet. In the summer, they are active from twilight to the early morning hours. In the winter, they only come out during the afternoon when the temperatures are warmest. Armadillos can carry slow-moving leprosy bacterium. Always wear gloves when handling armadillos - dead or alive - and cook meat thoroughly before eating. I don't plan to do this last thing.

They've been expanding northward from Texas and Mexico for more than 100 years.

Their armor may steal the show, but these little mammals they use to burrow underground. But they don't just stick


#### 10 Years Ago This Week - 2009

Over 1,100 Iowa National Guard soldiers were a part of the U.S Presidential Inauguration last Tuesday, and among them were two Grundy County natives. Mark Greiner who now lives in Holland with his wife Anne, and Trent Dirks, a Grundy Center native and now a Cedar Falls resident, both participated in the Inauguration as members of the Iowa National Guard Charlie Company 133rd Infantry. Greiner said they arrived in Washington D.C. Sunday morning, stayed at the Gage Eckington Elementary School in northwest D.C., and returned to Iowa Wednesday morning. They had a dress rehearsal Monday and were on duty from 11 p.m. Monday to 8 p m. Tuesday working nearly 21 hours straight. Stationed three blocks north of the US Capitol, the Iowa soldiers duties included crowd and traffic control and watching for suspicious behavior. "It was an honor to be chosen for it. I could say I was there [when Barack Obama was sworn in] even though I didn't get to see the actual inauguration," Greiner said. Although they were three blocks away, the capitol was between where they were stationed and inauguration, Greiner explained. Greiner said they were in radio communication with other law enforcement agencies and deputized by the Washington D.C. Police Department. They were authorized to arrest anyone who was out of line. However, Greiner said his unit did not arrest anyone.

A Pamida spokesman announced Friday, Jan 23 that they would be closing 11 stores nationwide, including the Grundy Center store on Saturday, Jan. 31. Dean Williamson, vice president of human resources at Pamida's corporate office in Omaha, Nebraska, said the decision was made over the course of the last few weeks. Pamida, 2201 Commerce Drive, has been in Grundy Center since 2000. when it was converted from a Place's, which had been there since 1998. Pamida currently has 215 locations in 17 states. Pamida team leaders in Grundy Center declined to comment on the situation. Williamson said the decision came down to economics. "The current state of the economy is not helpful for retailers," Williamson said. "Unfortunately, the sales at the stores [that are closing] are insufficient to keep them open." Williamson confirmed the Pamida store has been without a general manager for some time, although was not sure how long, and Pamida team leaders in Grundy Center would not disclose how long that has been the case. Williamson said they decided not to have a liquidation sale, but instead will be packing up the inventory and shipping it to other locations. Although they are closing the store Saturday, Williamson said they will need employees to pack up their inventory and fixtures for a couple weeks.

#### 25 Years Ago This Week - 1994

A proposed new elementary building in Grundy Center will be voted on in 2 weeks, but the planning for a new facility began more than a year ago. It was in early 1993 that Grundy Center teachers and administrators first met with an educational facilities planner, who gave staff a glimpse of the schools of the future and the potential for facility improvements in Grundy Center. Staff first toured modern elementary facilities in other Iowa communities, including Pella and Jefferson. What they found, according to Physical Education instructor Rick Schupbach, was eye-opening. "I was in awe," says Schupbach, who visited the Jefferson elementary. "I couldn't believe the things that were offered to their children that we can't begin to offer ours because of the shortcomings of our building. Schupbach says the school visits were a way of "expanding the horizons" of local teachers, who are trained in the use of technology but haven't had a lot of opportunity to utilize it because of facility limitations. He says the plans local teachers came up with would drastically improve the delivery of education at the elementary level, and proposed high school changes would be very welcome. too. "The open classroom concept at the high school is not an ideal learning environment. Today's learning takes place in an atmosphere where student exchange of dialogue and small group work is very important. It's infrequent that a class simply listens to a lecture anymore," says Schupbach. His health classroom is adjacent to the open IMC, which would be moved to the center of the High School/ Middle School under the bond issue proposal. The remaining space and surrounding classrooms would be closed off with a corridor and doors.

# Grassley Q & A: Flags for Fallen Heroes

#### Question: What is the Fallen Heroes Flag Act?

Answer: This federal law provides the American public one way to pay tribute to the legions of heroes across the country who pay the ultimate sacrifice in service to their neighborhoods and communities. Community helpers and first-responders who run towards danger to save others put their lives on the line, every day of the week, 365 days a year, in the line of duty. These ordinary individuals often take extraordinary measures to save neighbors and strangers, alike. Whether on-the-clock or off-the-clock, local law enforcement, fire fighters and emergency response crews serve on the front lines of public safety and go the extra mile to save lives. On any given day, these hometown heroes perform life-saving rescues with one mission in mind: to protect and serve. From house fires, to boating accidents, traffic collisions, medical emergencies or crime scenes, first responders are on the scene, often putting themselves in harm's way to save others. We owe a debt of gratitude for our first responders who report for work every day. We grieve for those who don't return home from the call of duty at the end of the day. For those heroes who lose their lives in the line of duty, Congress adopted legislation in 2016 to provide a symbolic measure of the public's gratitude and devotion for their patriotism and service. The Fallen Heroes Flag Act authorizes the U.S. Congress to provide a U.S. flag flown over the Capitol in honor of fallen heroes to memorialize their service and sacrifice. For the next two years, I am honored to also sign the certificates from the Senate that will accompany each flag flown over the people's house, the U.S. Capitol, in tribute to a fallen hometown hero. For grieving families left behind, the flag reflects the American spirit, patriotism and pride that unites our men in women in uniform. For those who serve in the Armed Forces to defend freedom and liberty on the battle field, Old Glory symbolizes valor, bravery and vigilance. For those who serve on the front lines as forces of good in our hometown communities, the stitches and stripes of the Star Spangled Banner represent the social fabric of civic life that connects neighbors in society. The Fallen Heroes Flag Act salutes those who gave their lives to make our communities safer and stronger.

#### 50 Years Ago This Week - 1969

Construction bids on the new Grundy Center municipal swimming pool will total about \$137,000 - well within the \$170,000 bond limit approved by voters here last summer - but the exact figure hinges on a city council decision to accept certain alternates. Apparent low bid on the general contract is \$69.870, submitted by Beck-Ericsson Construction Company of Cedar Falls. Low bid on the pool contract apparently was \$47,933 by Pathfinder Pools, West Des Moines. Brockway Plumbing and Heating of Grundy Center is the apparent low bidder on the plumbing contract, with a bid of \$13,860.

Agency chairman Dean Wiarda of Grundy Center said each warning siren will cost an estimated \$5,000 per unit. The sirens will be used to sound civil defense alerts as well as warning to area civilian populations in the even of natural disaster.

## Question: How can a surviving family member request a flag for their fallen hero?

Answer: The Architect of the Capitol administers the program and has set the following guidelines. A request must be submitted within 180 days of the fallen hero's passing. Only one request per fallen hero may be fulfilled. Requests must be made through a Member of Congress. Iowans who would like to have their fallen family member recognized with a flag flown above the U.S. Capitol may contact my office at (202)224-3744. Remember, there is no cost to families who qualify for the Fallen Heroes Flag program.

In addition to the Fallen Heroes Flag program, the Architect of the Capitol also will fly U.S. flags over the Capitol for constituents who would like to commemorate a special birthday, anniversary or event. Note, no flags are flown on Thanksgiving, Christmas or New Year's Day. A personal flag no larger than 8'x12' may be submitted for a \$7 fee plus shipping and handling; all flags must be made in the United States. Alternatively, flags are available for purchase in different sizes, in nylon or cotton. Requests must be made at least seven days in advance and must not exceed 45 days in advance of the requested flying date. Secure online payment is available. Payment must be received before a request can be processed. A certificate of authenticity that includes the personalized dedication will be shipped with the flag. To request and purchase a U.S. flag for commemorative purposes, go to the Constituent Services tab on my website at www.grassley.senate.gov.



# Confessing Our Sins

"If you forgive anyone's sins, their sins are forgiven; if you do not forgive them, they are not forgiven. –John 20:23 NIV

e live in paradoxical times While many share the most intimate details of their life on social media for all the world to see, the practice of confession as a spiritual discipline has fallen by the wayside. In surveys of practicing Catholics, three-quarters of them "report that they never participate in the sacrament of Reconciliation or that they do so less than once a year." (Center for Applied Research in the Apostolate) Among mainstream Protestant denominations, confession as a ritual is practiced only in the Lutheran church, and one wonders how often Christians of any sect adhere to the

Biblical injunction to "confess your

sins to each other and pray for each

other so that you may be healed."

(James 5:16 NIV) Whether as a

society we are more or less

confessional than in times past is



certainly debatable. Reconciliation tribunals. psychotherapy, encounter groups are arguably all modern versions of confession. The flip side of confession is the Biblical injunction to tell others when they have sinned: "If your brother or sister sins, go and point out their fault, just between the two of you." (Matthew 18:15 NIV) While it is easy to notice and point to the faults of others, we often chafe at the slightest perceived criticism, and instead of thanking the person for helping us to be a better person, we reject their critique. A periodic examination of one's conscience and a willingness to confess one's sins is healthy for the soul. Therefore, confess your sins and pray that you will be forgiven. -Christopher Simon







POSITIVE SHARING: Elementary Principal Mitch Parker shared Mrs. Zoske and Mrs. Garber's 4th grade students have been working in teams for a cross-subject area unit about weather and natural disasters. The students are working to become experts in an area such as blizzards. The students are reading books and online sources. As a team, the students decide the subtopic to then focus individually on example: avalanches. The team then develops a Google slide presentation that they will share with the class. In Mrs. Severson's 3rd grade science, classes are studying weather patterns. ELEMENTARY SCIENCE CURRICU-LUM REPORT: Elementary teachers Tiffanie Nederhoff, Vicki Anderson, Jill Van Cleave & Kristen Garber gave the elementary science curriculum report. In Kindergarten, students meet weekly and most standards align with the reading curriculum so the activities match the "Story of the Week". Forces and Interactions with animals, plants and their environment, weather and climate, engineering and design are the major areas of focus. There are also mystery science activities and STEM projects. In first grade, students meet twice in a six day cycle and the standards are: Waves and their applications in technologies for information transfer (sound and light waves). from molecules to organisms (how plants and animals survive) Earth's place in the universe and matter and its interactions. There are also mystery science activities and STEM kits for plants and force. In second grade, students meet twice in a cycle and the standards are: Structure and properties of matter, interdependent relationships in ecosystems, processes that shape the earth and engineering design. Foss Next Generation Science kits are used - solids and liquids, insects and plants, pebbles, sand and silt. STEM kits are used and students collaborate with classmates to design and build a pinball machine. In third grade the students meet each day but rotate with social studies on a 3-4 week cycle. FOSS Next Generation science kits are used, which aligns with the 3rd grade standards: Water & climate, structures of life, and force and motion. Students have built ramps to predict the pattern of motion of an object rolling down the ramp and also figured out the best design for a spinning top to work on a flat surface. In forth grade, Foss science kits are used and also mystery science activities. Foss kits are: Environments, soils, rocks and landforms and energy






