## **City council** hears concerns over proposed development

GRUNDY CENTER - The proposed development of a fiveplex apartment building on the former First Baptist Church lot could help the city recoup money spent purchasing, abating and demolishing the old church, but neighbors to the property aren't convinced the new development is the right fit for the area.

Back in July, the city sold the 801 7th Street lot to Echo Development group out of Cedar Falls. The developers expressed interest in building a five-plex apartment building, and submitted initial plans that detailed the structure.

On Monday night, several citizens voiced concerns about the proposed apartment complex during the Grundy Center City Council meeting, as the city council held the first reading of an ordinance to rezone

## **Dissolution Defeated**

G-R voters overwhelmingly reject petition to end district

REINBECK- Contrary to the message emblazoned on signs across the Gladbrook and Lincoln areas, somebody had to win, and somebody had to lose in the battle to dissolve Gladbrook-Reinbeck. That is, after all, the nature of both voting and elections.

Residents of the district, as

proposal to dissolve and divide the territory between Dike-New Hartford, GMG, Grundy Center, Hudson and North Tama by a wide margin on Tuesday: 69 percent voted no, outnumbering the "Yes" voters by more than a two to one margin. Now, the healing process begins, and the leaders behind the push for dissolution are left to scratch their heads and re-enter a loveless marriage bemost predicted, rejected the tween two communities that be-

came bitterly divided in the days leading up to the vote.

A total of 2,235 ballots were cast according to the unofficial results, which, if factoring in the 3,025 figure that was used as the baseline for the 20 percent requirement on petition signatures, means that almost 74 percent of registered voters went to the polls—one of the highest turnout rates for a school election in Iowa history.

"I believe that the election results show that the overwhelming majority of the Gladbrook-Reinbeck community supports the school district and endorses the work that we're doing," second year Superintendent David Hill said. "I think with such a strong turnout, we can really say that this is the will of the people of the Gladbrook Reinbeck school district."

### Supervisors receive bridge repair bids

GRUNDY CENTER- Grundy County Engineer Gary Mauer opened bids on a pair of bridge projects during Monday morning's regular supervisors meeting, and further action was tabled to provide time for a thorough review of the details.

Bridge I-1, a three-ton located about a mile and a half south of D35, is up for replacement, and Boulder Contracting of Grundy Center and PCI of Reinbeck were the only two bidders. Both bid on the same alternate, and PCI (\$249,823) came in about \$30,000 lower than Boulder (\$279,772). The engineer's estimate for the project was \$319,635.50.

The other project, Bridge A-05, is a box culvert on Westbrook Avenue, which runs along the Grundy-Butler County line, and three bids were received. PCI bid \$86,935 for a precast culvert, while Gus Construction of Casey (\$82,267.50) and Mc-Culley Culvert of Barnes City (\$113,738) each bid on a cast in place culvert. The engineer's estimate was \$106,467.

In other notes, Mauer told the board that portions of 270th Street would be closed next week.

Supervisor Barb Smith reported near the end of the meeting that both the Board of Health and the Landfill Commission are struggling to reach quorums at meetings, and the commission currently does not have a member from Stout, Holland or several of the rural townships.

"It seems to be a common problem with some of these boards and commissions," Smith said.

Smith also reported that a dispute between Greg Melcher,

## Several area break-ins reported

The Grundy Register GRUNDY CENTER - In between the late hours of Tuesday night and the early hours of Wednesday morning, burglars managed to break into two area businesses and one church, making away with cash from at least one of the locations.

The Landmark Bistro and the American Lutheran Church in Grundy Center and Spanky's restaurant in Gladbrook each reported thefts sometime between the evening of Tuesday, September 5 and the morning of Wednesday, September 6.

Landmark Bistro owner Jill Krausman said the culprits broke a lock on the door of her restaurant and stole a cash box containing \$300, but she added that nothing else aside from the door and the cash box was damaged or stolen during the break-

in.

Around the same time that night, a similar incident was reported at the American Lutheran Church in Grundy Center.

Pastor Luther Thoresen, told The Grundy Register there is no cash kept at the church, so the burglars didn't take anything. They did, however, damage one

of the doors.

This is the second time in two months that the ALC has been broken into: the first incident occurred between August 12 and August 13, though nothing was stolen in that attempt either.

A third business, Spanky's restaurant in Gladbrook, experienced a break-in roughly 2:00 a.m. on Wednesday, September it is currently unknown if the

The restaurant's owner, Mandy Boldt, posted several photos from a security camera on Facebook showing two burglars who appear to be male leaving her restaurant.

Boldt could not be reached for immediate comment, and thieves damaged or stole anything from the restaurant.

A request for comment from the Tama County Sheriff's Department was not immediately returned, and it is currently unknown if the three incidents are in any way connected to each other.

## **Osage man charged with** assaulting GC police officer

GRUNDY CENTER- An Osage man who allegedly resisted arrest and became combative toward officer Justin Fox has pled not guilty to a pair of felony charges stemming from an August 19 incident in Grundy Center.

Chase Christopher Penfold, age 29, is charged with Assault on a Peace Officer (a class D felony), Interference with Official Acts-Attempting Serious Injury (a class D felony) and Public Intoxication-Third or Subsequent Offense (an aggravated misdemeanor). According to a criminal complaint, Penfold, who was attending a wedding reception at the Old Fifty-Six just west of the Bacon Veneer, resisted being detained after multiple com-

mands to stop, then pushed Officer Fox several times before eventually swinging at him with a closed fist and hitting him on the head.

An arrest warrant was issued on August 23, and the Osage Police Department

served it on August 29. Penfold, who is being represented by public defender Jennie Wilson-Moore, made an initial appearance on August 30 and entered a written plea of not guilty. He was released from custody on September 1, and a pretrial hearing was scheduled for September 8.

Penfold has been charged with crimes on at least 15 other occasions, but this is the first time he has faced a felony in Iowa. Most notably, he was convicted of Second Degree Harassment in 2008, Domestic Abuse Assault in 2012, Operating While Under the Influence Third Offense in 2013 and Assault on Peace Officers and Others in 2014.

Fox could not immediately be reached for comment.

## **G-R community gathers** for 'final push' before vote

Less than 12 hours before polls opened in the Gladbrook-Reinbeck Community School District for the school board elections, a crowd of more than 200 people gathered in front of the high school in Reinbeck for a night of prayer and discussion of how to proceed after Tuesday's dissolution vote, regardless of the final result.

The overall message was one that advocated not only for a "no" vote to the dissolution proposal on the ballot, but also a call to action for those in the G-R community to foster stronger bonds across the divisions that the contentious issue has raised within the district boundaries.

Reinbeck pastor Terry Plocher began the event with a message of unity.

"We come not as voters, students, parents, staff, citizens... but as children of God," Plocher said.

The vigil, which was planned over the weekend, was inspired in part by G-R Superintendent David Hill's blog post last week that discussed the "final push" before the vote, in reference to cent Rebel graduates also spoke

win a second-consecutive football title.

"It was time to come together. ... Instead of being angry about something, we want to celebrate what we already have," Reinbeck resident Michele Knaack said of the inspiration for Monday's gathering. "This isn't a time for fighting and bickering."

Hill presented to the crowd the results of a project where G-R students were asked to describe what made G-R special in five words, with various students praising the school's teachers, athletic programs and community and then added his own entry: "The people standing here tonight."

Caleb Sieh, an assistant coach for the G-R boys' basketball team, implored the crowd to respect those in Gladbrook, no matter what their opinion was on the dissolution vote.

"We should encourage compassion going forward," Sieh, a Reinbeck resident, said. "Folks in Gladbrook are hurting. ... We can be rah-rah (about the vote), but what are we going to do to make the community better?"

Current G-R students and re-

Barry Thede, an assistant coach for the Grundy Center/ Gladbrook-Reinbeck boys soccer team, made a personal appeal with regard to a recent addition to the Thede family.

"I have a newborn over there," Thede said, pointing toward the crowd, "that I'd want to see be a Rebel. That would mean a lot to me."

Another Reinbeck pastor, Oscar Yturriaga, led the group in "The Lord's Prayer" to close the proceeding.

Before the crowd dispersed, attendees were led in one final cheer of "We are G-R!"

"This was a tremendous show of support, but I'm honestly not surprised by it because this school has tremendous support," Hill said. "We have every reason to believe that we can continue to do an incredible job serving kids for many more years to come and that we have a bright future once we get past this vote tomorrow.

"I hope that when it's all over that we can remember that every part of the Gladbrook-Reinbeck school district is a part of this community, from Gladbrook to Reinbeck, to the rural towns all around the district. Every student here is important, and we're here to serve them."

the property from R1 (single and double family residential) to R2 (multi family residential).

Kay Graham who lives next to the former Baptist Church property, says she is glad the city removed the old church, but that she would prefer to see something else take it's place.

"I lived next to that big church for 25 years, and now that it's finally gone, I'm loving the openness, but I'm a little concerned about what might be going [up on the lot]," Graham said. "I think some housing would work, but it has to be housing that would fit there. I think the large apartments would probably be too overwhelming for the area, and I would like to have something that would not be so confining there. I think we all need to have some openness there and something that's attractive for the community."

Another local resident, Kevin Kuester, said he thinks everyone on the council should look at the issue as if they live next to or near the former Baptist lot.

"If you lived there, would you want that building there?" Kuester said. "Forty five feet high for a three story building; it's going to overshadow everything and to me look way out of place on that lot, compared to all the other structures. I guess I'd rather see a three-plex or something smaller, like that."

Council member Janetta Miller mentioned that a marketplace analysis showed Grundy Center needs more housing options like the one proposed by Echo Development.

"We had talked to the developer about maybe doing a one-story development, but our marketplace analysis indicates we need more of this sort of housing for young professionals moving to town," Miller said. "A lot of the young professionals that work here, like teachers and nurses, are living in Cedar Falls and driving here for work. When they don't live here, they're not spending here. They're not eating here, they're not grocery shopping here, and they don't stay here because it's easier for them to move on to the next opportunity when they don't have roots here. We want to have something here to help them grow their roots here in Grundy Center."

and hobbling in on their canes," the worker said. "Pretty much everyone who can breathe wants to vote today."

Incumbents Doug Rowe of Gladbrook, Rod Brockett of Reinbeck and Susie Petersen of rural Lincoln were all re-elected to the school board in uncontested races, and newcomer Christine Farley of Reinbeck won a seat with 1,386 votes. Surprisingly, Rowe got the most votes of any candidate at 1,571 and received almost 400 more votes in the Gladbrook precinct than any of the others on the ballot, but he was disappointed by the overall turnout in his area: just 849 votes were cast in the Gladbrook and Lincoln precincts compared to almost 1,400 in Reinbeck.

"The voters have spoken. You have to move forward and make the best of it, but right now, I don't have any solutions," Rowe said on Tuesday night. "I expected a high turnout from the north end of the district because they had a lot more to lose than we do... (but) I thought the turnout from the Gladbrook area would be stronger than it was."

Perhaps the most intriguing subplot of the whole ordeal was the drama that percolated in the final week before votes were cast: Gladbrook-Reinbeck football players arriving at "The Pit" for their homecoming game against North Tama last Friday entered a community covered in "Vote yes, it is just that simple" signs, and mailers that some (incorrectly) believed to be sent from the school itself targeted voters in the Reinbeck area, encouraging them to vote for the dissolution to avoid a potential whole-grade sharing or consolidation agreement with bitter rival Grundy Center. The content of the letters amounted to a rehashing of the talking points parroted by pro-dissolution leaders Mike Bearden and Keith Sash at several meetings over the last two years. Bearden, who ran a last minute advertisement on the television station KWWL on Monday evening urging "Yes" votes, could not be immediately reached for comment after the results were released on Tuesday. Just days later, a prayer vigil held just off of district property but near the high school in Reinbeck on Monday night sparked further controversy over whether the anti-dissolution factions were using school resources to promote their position. Grundy County Sanitarian Carie Sager, a G-R graduate who currently resides in Reinbeck, shared a photo of the vigil-with over 200 attendees-that quickly went viral. "I truly believe it is time to reunite our district and make G-R stronger than ever...We all need to come together and be one community," Sager said in an e-mail after the vote on Tuesday. "Now, let me dry my tears

## Local school board election results released

The Grundy Register As of late Tuesday night, the unofficial school board election results for the five area districts are in.

At AGWSR, Lanae Metzgar and Anthony Sillman beat out candidate Chris Sailer in the District One race. Metzgar and Sillman will take seats on the school board representing District One, while Josh Meyer will gain a seat representing District Two.

At BCLUW, the three incumbents - Eric Engle, Lynne Kock and L.J. Kopsa - will each retain their seats. Their only opposition was a write-in, Kay Feltz, which garnered one vote.

At Dike-New Hartford, Ashlee Tott beat out Alan Shakespeare for the District One seat, while Ben Freese took the District Three seat by a majority with the only opposition coming from a write-in, Sarah Petullo, which gained 20 votes. Newcomer Anjuli Meyers ran for an at-large seat held by incumbent Christa Lotts, but Meyers lost out to Lotts by just shy of 50 votes.

At G-R, three incumbents - Douglas Rowe, Susan Kerns-Petersen and Rod Brockett - will each retain their seats after running unopposed. Christine Farley successfully ran for a seat vacated by the departure of Josh Hemann.

In Grundy Center, three newcomers - Andy Lebo, Mandy Yoder and Alan Kiewiet - ran unopposed for three open seats, and will each gain a seat on the Grundy Center School Board.

## Doggie dip raises money for GC Aquatic Center

The event, sponsored by Abels Funeral Home, managed to raise nearly \$300 for renovations at the pool.

Rebecca Camp, managing funeral director at Abels Funeral Home, said the first ever 'Doggie Dip' was a success, and they hope to make it a yearly event.

"We have been trying to put

this event on for years, so a big thank you to Heather Stumberg, our mayor Brian Burrow and Dan Bangasser for making this event possible," Camp said. "Our funeral home staff is always trying to give back to our communities and we thought this would be a great event! We plan on making this an annual outing so we hope to see more families and pets next year!"

The money raised will go to make repairs at the Grundy Aquatic Center, including repairs on umbrellas, the lily pad feature and the children's play feature.

Council member Al Kiewiet added that Echo Development was the only group to make the city a proposal.

"There were no other offers to put anything there by any other developer anywhere in the community," Kiewiet said.

Unlike a park or green space, putting housing on the lot would bring in property taxes for the city, and over time, help the city recoup the money they spend purchasing, abating demolishing the former and Baptist Church.

Miller added that the developer is also looking at developing more properties in Grundy Center.

"This developer isn't just looking to invest in Grundy as a one and done," Miller said. "This developer is looking into investing in Grundy by building houses and other rentals."

After the discussion, the council held the first reading of the ordinance to rezone the property from R1 to R2.

City Clerk Kristy Sawyer explained that the rezoning ordinance simply provides the necessary requirements for the developer to build a multi-family residential unit once the developer agreement has been signed, but the city has still not signed a developer agreement as of now. In the future, a developer agreement detailing the specifics of the proposed structure will be presented in front of the council, and will need to be signed off on before any work begins on the proposed apartment building.

A district ravaged by a crisis of its own making must now attempt to rebuild, and it still has the lowest overall enrollment in the area. It still has one of the highest open enrollment out rates in the state, and it still has two primary communities separated by 17 miles with more than a hint of disdain for each other among certain generations. Can the Rebels come back together?

"Treating us as an equal member would be a big improvement," Sash said. "And treating us as if we are a part of the school district rather than just a pain in their side."





## Northey comments on Iowa Crop **Progress and Condition Report**

DES MOINES - Iowa Secretary of Agriculture Bill Northey today commented on the Iowa Crop Progress and Condition report released by the USDA National Agricultural Statistical Service. The report is released weekly from April through October.

"Farmers continue to gear up for another harvest and we're seeing more activity in fields across the state as about 15 percent of corn and 8 percent of soybeans have reached maturity," Northey said. "Moving into harvest season, the crop is very variable across the state with 60 percent of corn and 61 percent of soybeans rated as good to excellent condition."

The weekly report is also available on the Iowa Department of Agriculture and Land Stewardship's website at www.IowaAgriculture.gov or on USDA's site at www.nass.usda.gov/ia. The report summary follows here:

### CROP REPORT

It was another dry week in Iowa with only localized showers during the week ending September 10, 2017, according to the USDA, National Agricultural Statistics Service. Statewide there were 6.8 days suitable for fieldwork. Activities for the week included cutting hay, chopping corn for silage, seeding cover crops, hauling grain, and preparing for grain harvest.

Topsoil moisture levels rated 17 percent very short, 32 percent short, 51 percent adequate and 0 percent surplus. South central and southeast Iowa continue to be the driest parts of the state with over 80 percent of topsoil moisture rated short to very short. Subsoil moisture levels rated 19 percent very short, 34 percent short, 47 percent adequate and 0 percent surplus.

Seventy-six percent of the corn crop has reached the dent stage or beyond, three days behind the 5-year average. Fifteen percent of corn had reached maturity, six days behind last year and eight days behind average. Corn condition rated 60 percent good to excellent. Forty-seven percent of soybeans were turning color, one day behind average. Eight percent of soybeans were dropping leaves, four days behind average. Soybean condition rated 61 percent good to excellent.

The third cutting of alfalfa hay was 95 percent complete, over one week ahead of last year. There were some reports of producers starting to cut their fourth crop of alfalfa. Pasture conditions declined to 41 percent poor to very poor due to continued dry conditions slowing growth. Livestock conditions remained good, with reports of cattlemen weaning calves.

### **Iowa Preliminary Weather Summary By HARRY HILLAKER**

It was a very dry week across Iowa with mostly below normal temperatures. Very light rain fell over portions of north central and northeast Iowa on Monday (4th) and Tuesday (5th) with Britt reporting the most rain with only 0.13 inches. Thunderstorms were scattered over portions of northwest and far western Iowa on Saturday (9th) evening into Sunday (10th) morning with a maximum of 0.63 inches of rain reported at Akron. Otherwise no rain fell at all over most of the southern two-thirds of Iowa during the week. The statewide average rainfall was 0.03 inches while normal for the week is 0.84 inches. This was the driest week since mid-February. Meanwhile, temperatures were above normal on Sunday (3rd) and again the next Saturday (9th). In between unseasonably cool weather prevailed for the work week, especially on Tuesday (5th) and Wednesday (6th) when daytime highs were only in the sixties in most areas. Temperature extremes for the week varied from a Sunday (3rd) afternoon high of 88 degrees at Oskaloosa to a Thursday (7th) morning low of 35 degrees at Stanley (Buchanan County). The statewide average temperature was 4.0 degrees below normal for the week.

### Eight Grundy County farms earn special designations at State Fair

GRUNDY COUNTY- Grundy County has always been known for its soil and its agricultural tradition, and eight local operations were recognized with Century and Heritage Farm awards for 100 and 150 years, respectively, in the same family at the State Fair in Des Moines last month.

This year's Century Farm honorees all hailed from the northern half of the county: The Bakkers (Curt, Jeff and Larry) and the Johnson-Hubergs (Gail, Lori Huberg-Mulder and Jody Huberg-Schipper) hail from Dike, and Ronald DeBoer is from rural Aplington. The farm of James and Brenda Everts is



IVESTER- If you live in the Ivester area, there's a pretty good chance that you farm. The territory in western Grundy County is known for its fertile soils and longstanding family tradition, and one of those families, the Shellers of rural Eldora, were recently honored at the state fair with a Heritage Farm 150-year designation.

Daniel Sheller first purchased the land-240 acres-from a couple that had homesteaded the plot and then left, and he and his brother moved to the area from Illinois in 1866. Their wives stayed back in Illinois for six months while they got settled, and upon their arrival, both the men and the women were expecting the other group to prepare a large meal to christen the new farm.

"Nobody had fixed anything or planned anything," Keith Sheller said.

Still, the farm survived, and it's gone through four generations since then. Sheller and his wife Dorothy are still farming to this day.

"My dad always wanted that, so it just kind of got stuck in my head," Keith said. "Hang onto it, and keep going.'

These days, the Shellers stick to grain farming after previous forays into livestock and dairy farming and rent some of their land from other nearby owners, including Keith's brother Dan. As most of the Heritage Farm recipients can attest, farming has changed dramatically over the last 150 years, and Sheller can still remember picking corn by hand as a boy. He first started farming full-time in 1963, and he married Dorothy, a Beaman-Conrad High School graduate, in 1972.

"It's scary, (but) the bigger changes I liked were that I didn't have to pick corn by hand and didn't have to mess with horses," Keith said.

The Shellers, along with the Millers of Beaman (who were previously chronicled in The Grundy Register) and the Wheelocks of Conrad, were one of three families from Grundy County honored this year and 119 total in the state of Iowa.

Most people who choose poverty as a way of life have already received a good education, and their health is probably suffering from having too much rather than too little to eat. They choose poverty to help the poor. Mother Teresa claimed that poverty makes us free, free from the entanglements of material things and the worries that they bring. Poverty, when chosen freely, can bring joy and single-minded devotion to what really matters. One way to get there, or to move closer to this virtuous poverty is to simply give more. As Mother Teresa often said, we should give until it hurts. - Christopher Simon





## Iowa celebrates archaeology in September and October



September and October will be big months for Iowa's Archaeologists as the Office of the State Archaeologist coordinates educational programming throughout the area.

Based out of the University of Iowa, the Office of the State Archaeologist is a research unit that employs 25 professional scientists who investigate, study, and archive the histories of all the people that have lived in Iowa throughout the ages. Mandated by Iowa Code, the State Archaeologist is tasked with preserving knowledge of Iowa's human past and acting as stewards for important cultural artifacts.

While many towns in Iowa are celebrating their 125th anniversaries, that history barely scratches the surface of Iowa's past. Long before Iowans loaded up their rifles and shotguns for dear and pheasant season, Paleo-Indians hunted mastodons with stone spears as the last ice age came to a close. Traces of their pre-historic civilization, such as pottery or carved animal bones, can still be found today.

"Many people don't know the time depth that we have here in Iowa," said Archeology Technician Specialist Chérie Haury-Artz. "People have been in Iowa for more than 13,000 years and we've got artifacts from that whole time period."

People often associate archeology with globe trotting adventures, navigating jungles and deserts in search of ancient cities and ruins. The reality isn't quite as dramatic, particularly in Iowa where the prehistoric civilizations were relatively nomadic, leaving behind few permanent structures outside of burial mounds and earthworks Still, that doesn't mean all evidence of Iowa's first settlers has been lost to time. The State Archaeologist office collects and catalogues historical artifacts from Iowa's history, maintaining two large repositories of ancient discoveries that shed light on the cultures that have inhabited the area. "We have a huge database that

public.

collects all that information," said Haury-Artz. "It's available to any researchers that want to learn more about archeology."

The State Archeologist also works closely with the Iowa Department of Transportation to protect historical sites across Iowa. Before bridges and highways can be built, cultural resource surveys are done to make sure new projects don't destroy archeological properties.

If the survey does find items of historical significance, sites are excavated to make sure Iowa's history is preserved before literally being paved over.

Occasionally more than just tools and weapons are found as well. The bio-archeology program is charged with identifying and protecting human remains. Working closely with area Native American communities, the department can determine which tribe an ancient skeleton might belong to so that the remains can be dealt with in an appropriate manor. Few people may know that the state has an archaeology department, but upcoming outreach plans may help remedy that. From

September 18 through October

21 is Iowa Archaeology Month, where the state's archaeologists will team up with other like-minded organizations to promote a series of programs for the general

"This is a time where we focus on archeological programming that takes place all across the state," said Haury-Artz. "Not everybody can make it to Iowa City for a talk, so we advertise for programs all over the state to give people an idea of what's going on in their area."

On September 21, the Louisa County Conservation Board will host a program about the protection of ancient human remains. It will be Archaeology Day in Cherokee on September 24 as the

Iowa Archeological Society hosts a day of activities for children and adults. Over in Elkader, Osborne Heritage Days will take a look at the pioneer era at Osborne's Pioneer Village on October 14-15.

"We just hope to make people aware of the heritage of our state. We think it's pretty interesting," said Haury-Artz. "It's also a great hook for education."







"From the beginning it was really fast," Fisher said. "I just tried to stay up front, didn't want to get too far behind, and ended up going back and forth with a lot of the girls. They might pass me going uphill and then I'd pass them again on the downhill. Worked out well for me."

Fisher was 28 seconds off meet winner Hannah Brown of Dubuque Hempstead. West Des Moines Dowling won the team title with 67 points. Grundy Center/Gladbrook-Reinbeck placed 12th with a 380 score. followed by Dike-New Hartford in 13th with 430 and BCLUW rounding out the area teams with an 18th place finish and a 553 team score.

In her junior season, Fisher is not far off from her personal best set at last season's state cross country meet, where she finished 11th in 19:24.

"I ran a lot over the summer and got into better shape for this season," Fisher said. "It mostly just helped that I've had a lot of experience running (Marshalltown) for the past two years, I knew what I was getting into and who I'd be running against.

"I think we did pretty well as a team considering we went against a bunch of 4A schools. We've got a lot of stronger varsity runners and we're getting the spread a lot lower."

GCGR was led by Lily Ehlers in 51st place in 20:55. Cora Saak was 70th in 21:52.

"We were really proud of the kids for the way they competed," GCGR head coach Andy McQuillen said. "The girls team ran outstanding. ... Shelby Rivera, Sarah Lindeman, Libby Ross and Madison Westwater area all improving for us, which is crucial to the success of the team throughout the season."

Ellie Foster led the Wolverines with a 71st-place finish in 21:52, with Sierra Loger finishing 82nd in 22:36. Kaity Houts was 92nd in 23:32.

"Like on Tuesday (at Waverly), the boys showed improvement," McQuillen said. "Max Schweppe and Sam Schildroth are both continuing to be factors for this team."

## school golf returning to 4 classes

The Iowa Girls High School Athletic Union's Board of Directors voted unanimously to condense girls' high school golf in the state back from five classes to four classes at its Sept. 7 meeting.

The change will take effect next spring, with the largest 50 schools competing in Class 4A, followed by the next 60 largest in 3A, the next 80 largest in 2A and the rest in 1A.

This also rearranges the postseason layout, particularly for first-round regional meets in 1A and 2A on May 14. In 1A, there will be 15 first-round regional meets (eight teams per site) while 2A will have 10 firstround regional meets.

All regional final meets will be held May 21. 3A and 4A will have 12 and 10 teams each, respectively, at their regional final sites. The top two finishers and top eight individual finishers from each regional final site in all four classes will advance to the state golf meet on May 29-30.
